



## PICK UP AFTER YOUR PET

Residents are reminded that Ordinance #40 mandates that pet owners must pick up their dog feces when walking their dogs through the community.

**Please note that pets are NOT permitted in the Town Park**

Note: this includes the entire park—playground, pool, fields, etc.

Not only is it a violation against Ordinance #40, it is also a safety hazard for children playing in the playground area.

Individuals are encouraged to call 911 to report offenders to the Evans City/Seven Fields Regional Police Department.



## Ordinance #66

### Section VI. Trimming of Trees and Other Plants Along and Above Sidewalks

...it is the duty of occupants and owners at all times to keep hedges, bushes, shrubbery and trees trimmed as not to obstruct the sidewalk...or the view of motorists along intersecting streets...limbs of trees shall be deemed an obstruction if they are permitted to overhang the sidewalk at a **height of less than seven (7) feet...**



**Borough Officials are actively enforcing the Ordinance.**

Take the necessary steps to be aware and be compliant—avoid the fine.

## Seven Fields Burning Ordinance

Residents are reminded that Ordinance No. 16 stipulates that open burning and incineration within the Borough is prohibited. This includes the burning of leaves and trash, etc.

Recreational fires are permitted but require a permit issued through the Borough Office. The "Recreational Campfire Permit" form is available online or at the Borough Office. **The permit is free and is valid for two weeks.**

Any person who violates any provisions of the Ordinance shall upon conviction, be fined not less than \$50.00 for the first violation, and not less than \$50.00, or more than \$300.00 for the second and succeeding violations.

### PENNSYLVANIA'S SCHOOL BUS STOPPING LAW

*Keeping Children Safe*

#### PENNSYLVANIA'S SCHOOL BUS STOPPING LAW

- ◆ When you meet or overtake a stopped school bus with red signal lights flashing and stop arm extended, you **MUST STOP**.
- ◆ When you approach an intersection where a school bus is stopped with red signal lights flashing and stop arm extended, you **MUST STOP**.
- ◆ You **MUST STOP** at least ten (10) feet away from the school bus.
- ◆ You **MUST WAIT** until the red lights have stopped flashing and the stop arm has been withdrawn before moving.
- ◆ **DO NOT MOVE** until all the children have reached a place of safety.

#### KNOW YOUR RESPONSIBILITIES

- ◆ 1.5 million children are transported on Pennsylvania roads each day.
- ◆ These children are transported more than 346 million miles to school each year.
- ◆ Every year, children are needlessly injured or killed by drivers passing stopped school buses.



You **MUST STOP** on roadways with painted lines.



You **MUST STOP** at an intersection, whether it is or is not marked with a stop sign. All traffic **MUST STOP**.



You **MUST STOP** on roadways with ridged/grooved dividers.

#### PENALTIES

If you are convicted of violating Pennsylvania's School Bus Stopping Law, you will receive all of the following penalties:

- ◆ 60-Day Driver's License Suspension
- ◆ Five (5) points on your driving record
- ◆ \$250 Fine

#### Renter Responsibilities

- The security deposit is required when reservation is made. The check will be held until after your event and returned to you un-cashed as long as no damage occurs during your event.
- You may pick up the key and pay your balance due the day before your rental. If you rent on a Sunday, please pay the balance due and pick up the key on the Friday before.
- The renter is responsible to clean the facility in accordance with the check list.
- The key and checklist must be returned the following working day by noon. You may drop the key with the checklist in the black drop box outside the Borough Office front door.
- The security deposit will be returned to you within two weeks after your rental as long as the facility is cleaned in accordance with the checklist, the key is returned and no damage is found upon inspection.


