Patrol Officer Jason Giallorenzo



Officer Jason Giallorenzo is one of the recently hired officers of the Evans City/Seven Fields Regional Police Department, joining the department in March 2015. He decided that he wanted to pursue a career in law enforcement near the end of his senior year of high school. What ultimately inspired him to pursue a career in law enforcement was not only the fact that he wanted a career where he could help people and make a difference, but his friend's father. Officer Giallorenzo's parents divorced when he was young so his friend's father played an active role in his life with significant influence. His friend's father is currently a Chief of Police in a neighboring jurisdiction of his hometown, and seeing how personable he was while working and providing for his family inspired Officer Giallorenzo to want to be able to do the same. Ordinance #66

Section VI. Trimming of Trees and Other Plants Along and Above Sidewalks

...it is the duty of occupants and owners at all times to keep hedges, bushes, shrubbery and trees trimmed as not to obstruct the sidewalk...or the view of motorists along intersecting streets...limbs of trees shall be deemed an obstruction if they are permitted to overhang the sidewalk at a **height of less than seven (7) feet...**



Borough Officials are actively enforcing the Ordinance.

Take the necessary steps to be aware and be compliant—avoid the fine.


