Ordinance #45 (Amended April 11, 2011)

SEVEN FIELDS TOWN PARK POOL RULES AND REGULATIONS

1. The swimming pool will be available for open swim from 11:00 a.m. to close at 8:00 p.m. Monday - Friday and from noon to 8:00 p.m. on Saturdays and Sundays. The pool will be opened limited hours on weekdays from 4:00 p.m. to 8:00 p.m. at the startup of the season through Friday, June 10, 2011 and again the last week of pool operation from **date TBD** through September 5, 2011.
2. Passes must be presented upon admission. Annual membership passes are available to Borough residents at the following rates:

<u>Resident:</u>	Family: \$150	Single: \$70	Senior Single (over 60): \$55
<u>Non-Resident:</u>	Family: \$175	Single: \$95	Senior Single (over 60): \$80
3. Children under 10 years of age will not be permitted unless accompanied by a person 16 years of age or older, who possesses a pool pass, who shall be responsible for their safety and proper conduct. Children under 5 must be accompanied in the water by a responsible adult. Children will be required to demonstrate their ability to swim one width of the pool without a floatation device or other assistance to enter the deep end of the pool alone. No person under the age of 18 is permitted in the pool areas during adult activities (i.e. adult water volleyball, lap swims, etc.)
4. The following are prohibited in the pool and /or pool area:
 - Floats, except for small children accompanied by an adult, *i.e.* water wings and life jackets are allowed on young children.
 - All food is to be kept away from the pool deck
 - Alcoholic beverages or glassware of any kind
 - Water guns
 - Dogs, pets and other animals
 - Chewing gum is not allowed in the water.
5. Use of the pool when lifeguard is not on duty is forbidden. Lifeguards have full authority to expel or discipline any violators of the pool regulations or posted signs.
6. Diving, running, shoving, dunking and/or "cannon balling" into the pool is prohibited.
7. All swimming is at the individual's own risk and responsibility. All persons while in the pool or pool area shall comply with the directions of the lifeguard or other supervisory personnel of the Management. Any personal injury sustained on the pool premises must be immediately reported to the lifeguard or management office. The Management will not be responsible for loss, damage or destruction of any personal property or any accidents resulting from the use of the pool or other facilities.
8. Before entering the pool, all bathers must observe the sanitary regulations of the Health Department as may be posted by the Management. No person with a fever, cold, cough, inflamed eyes, any skin disease or wearing gauze bandages shall be allowed to use the pool. All persons who have used oil, ointments or lotions must take a soap shower before entering the pool.
9. All persons must be properly attired upon entering and leaving the swimming pool area. (Bathing suits only - no jeans allowed in pool).
10. Only one person is permitted on the slide at a time, feet first only.

11. The Management reserves the right to close the pool when necessary due to repairs, inclement weather (below 65 F, heavy rain, thunderstorms, tornadoes, lighting) or any other safety factors.
12. The Management reserves the right to limit the number of persons to the estimated capacity of the pool and facilities available.
13. Chairs and lounges cannot be reserved.
14. Parents should not call down to the lifeguard to ask to send their children home, or for any other reason except in an emergency.
15. The lifeguard reserves the right to refuse admittance or request removal of anyone in an intoxicated state.
16. No smoking is permitted within the confines of the pool fence.
17. Bicycles, skateboards, or rollerblades will not be permitted in pool area at any time.
18. Guests will be permitted to enter the pool only upon presentation of a guest pass. All guests, including children over 3 years of age must present a guest pass to gain admittance to the pool area. Guest passes may be purchased at the Concession Stand at the following rates:

Resident: Adult: \$5.00 Child (3-17): \$3.00 Senior (over 60): \$3.00 Children under 3: Free
Non-Resident: Adult: \$8.00 Child (3-17): \$5.00 Senior (over 60): \$5.00 Children under 3: Free

19. The Management has the right to refuse admittance to any member holding a pool pass when the member is not in good standing without recourse to the Management. The pool manager may suspend pool membership privileges for 14 calendar days commencing the day of the third behavior offense by a pool member.
20. These rules and regulations may be changed, amended or added to at any time by the Management. Any infraction of these rules now or hereafter in effect shall subject the violator to having his pool pass confiscated, without recourse to the Management. No refund will be made on confiscated pool passes.
21. Rest periods will be at the discretion of the lifeguards to rest children and to offer opportunity for adults to swim.
22. Children wearing diapers must wear plastic or rubber pants over diapers (including disposable).
23. The pool member, whether a resident or non-resident, is responsible for the behavior of and observation of the rules and regulations by his guest. Passes are only valid for the year for which they were purchased and are nonrefundable and nontransferable.

Page 1; #2-Membership Rates:

Resident; Family Pass: \$160.00 Single: \$75.00 Senior Single (over 60): \$60.00

Non-resident; Family Pass: \$185.00 Single: \$100.00 Senior Single (over 60) \$85.00

Page 2; #18-Guests (Daily) Passes:

Resident: Adult \$7.00 Child (3-17): \$5.00 Senior (over 60): \$5.00

Children under 3-free

Non- Resident: Adult \$10.00 Child (3-17): \$7.00 Senior (over 60): \$7.00


