

# BOROUGH OF SEVEN FIELDS

## Ordinance #56 (Amended April 27, 2015)

An Ordinance of the Borough of Seven Fields, Butler County, Pennsylvania establishing the Borough's recreation fees and discount period for 2015.

WHEREAS, the Borough of Seven Fields shall be providing the following services, available to the public at the times by the Borough of Seven Fields, for the fees as set forth hereinafter;

WHEREAS, the Town Park Pool fees, which are available to all Borough residents and non-residents are as follows:

\*For membership pass purposes, a FAMILY is defined as parent(s) and any unmarried children ages 22 and under who are residing in the same household. Children who are 22 and over living at home and any other relative or individuals in the household may be subject to proof of residency.

A verification form must be submitted to the Borough Office by the family for the Nanny Pass to be issued. The Nanny Pass will only be issued to bona fide babysitters and are only permitted pool access when accompanied by the children for whom they have registered with the Borough that they baby sit.

WHEREAS, the following services and fees, which are available to all residents and nonresidents, regardless if they are members of the Town Park Pool or not, are as follows:

### **Swimming Lessons**

<b>Town Park Pool Swimming Lessons Levels I to VI</b>	
Resident	\$60 per session per child
Nonresident	\$85 per session per child

### **Pool Party Package**

<b>Town Park Pool Party Package</b>	
Resident	\$300.00
Nonresident	\$325.00

The Town Park Pool Party Package includes: Two (2) hours use of the Borough Community Center, noon – 2:00 p.m. or 4:00 p.m. – 6:00 p.m. and ten (10) Town Park Pool guest passes to be used the day of the party.

Reservations must be made at least one (1) week in advance. All pool rules apply.

The Community Center refund/cancellation policy (Ordinance #55) applies to the party package with the exception that if the pool is closed by management, the Borough will refund the renter \$100 of the fee.


WHEREAS, the above fees have been reviewed by the Seven Fields Borough Council and it has been determined to be in the best interest of the Borough to charge these fees for services.
