**ORDINANCE NUMBER 81**

**AN ORDINANCE OF THE BOROUGH OF SEVEN FIELDS, COUNTY OF BUTLER, COMMONWEALTH OF PENNSYLVANIA, AMENDING THE BOROUGH OF SEVEN FIELDS, BUTLER COUNTY, PENNSYLVANIA ZONING MAP BY 1) EXTENDING THE PEDD-PLANNED ECONOMIC DEVELOPMENT DISTRICT INTO THE EXISTING R-4 HIGH DENSITY RESIDENTIAL DISTRICT THEREBY EXTENDING THE PEDD-PLANNED ECONOMIC DEVELOPMENT DISTRICT AND REDUCING THE R-4 HIGH DENSITY RESIDENTIAL DISTRICT; 2) COMBINING THE "B-1 VILLAGE CENTER DISTRICT" AND THE "B-2 CONVENIENCE COMMERCIAL DISTRICT" INTO ONE DISTRICT REFERRED TO AS THE "B-BUSINESS DEVELOPMENT DISTRICT AND ELIMINATING THE "B-1 VILLAGE CENTER DISTRICT" AND THE "B-2 CONVENIENCE COMMERCIAL DISTRICT" ; 3) CREATING A NEW "I-INDUSTRIAL DISTRICT" IN PART OF WHAT IS CURRENTLY THE PEDD-PLANNED ECONOMIC DEVELOPMENT DISTRICT.**

**WHEREAS**, the Council of the Borough of Seven Fields, by Resolution No. 2013-14, adopted on February 11, 2013, adopted a comprehensive plan.


**WHEREAS**, certain modifications to the official zoning map are recommended and necessary in order to implement and maintain consistency with the comprehensive plan.

**WHEREAS**, the Council of the Borough of Seven Fields, Butler County, Commonwealth of Pennsylvania, deems it to be in the best interest and the general welfare of the citizens and residents of the Borough to update and amend the official zoning map.


