

**BOROUGH OF SEVEN FIELDS, BUTLER COUNTY, PENNSYLVANIA**

**AN ORDINANCE OF THE BOROUGH OF SEVEN FIELDS, BUTLER COUNTY, COMMONWEALTH OF PENNSYLVANIA AMENDING ORDINANCE # 55 TO PERMIT THE POSSESSION AND CONSUMPTION OF ALCOHOLIC BEVERAGES IN THE BOROUGH COMMUNITY CENTER AND IMPOSING REGULATIONS AND FEES RELATING THERETO**

WHEREAS, the Council of the Borough of Seven Fields desires to revise Borough Ordinance # 55 to include provisions for the responsible possession and consumption of alcoholic beverages in the Borough Community Center located in Town Park under the authority of a permit granted by the Borough, subject to certain regulations;

WHEREAS, the Council of the Borough of Seven Fields deems it in the best interest and general welfare of the citizens and residents of the Borough to amend the Ordinance.

NOW THEREFORE, BE IT ENACTED AND ORDAINED by the Council of the Borough of Seven Fields, Butler County, Commonwealth of Pennsylvania that Section J. of Ordinance # 55, is hereby amended in its entirety to read as follows:

J. No alcoholic beverages or controlled substances may be possessed or consumed within the Borough Community Center or on any publically owned property in the Borough. Provided, however, possession and consumption of alcohol may be permitted in the Borough Community Center, subject to the following:

- (1) The possession and consumption of alcoholic beverages in the Borough Community Center shall only be allowed under the authority of a Permit granted by the Borough Manager or his designee. The Fee for this permit shall be \$50.00 and shall be thereafter established by resolution of Council from time to time.
- (2) The Borough Manager, or his designee, shall issue regulations implementing rules for the possession and consumption of alcoholic beverages in the Borough Community Center, including, but not limited to:
  - a. A process for the issuance of permits, posting of permits and expiration of permits.
  - b. Designating locations, and perimeters around said locations, where possession and consumption of alcoholic beverages may occur.
  - c. Requiring compliance with state laws and local ordinances.
  - d. Addressing liability, indemnity and waivers.
  - e. Requiring permittees to provide proof of legal age to possess/consume alcoholic beverages.
  - f. Identifying appropriate containers for alcoholic beverages.
- (3) No person shall bring any alcoholic beverages into the Borough Community Center in glass bottles or containers, nor shall any beverages be served in glass containers.

Repealer. All provisions of previous Ordinances of the Borough of Seven Fields which are contrary to this Ordinance are expressly repealed.

Saving Clause. In all other respects, all Ordinances of the Borough of Seven Fields shall remain as enacted and ordained.


Severability. The provisions of this Ordinance are declared to be severable, and if any section, subsection, sentence, clause or part thereof is, for any reason, held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of any remaining sections, subsections, sentences, clause or part of this Ordinance

Effective Date. This Ordinance shall take effect in accordance with law.
