Resolution No. 2024-13 (Disposition of Borough Records)-Borough Council authorized Resolution No. 2024-13, the disposal of municipal records. Utility and paid services receipts (water payment receipts), bank statements & reconciliation files, accounts payable and receivable files can be dispositioned after (7) years per Municipal Records Manual.

<u>2024 Pyrotecnico Fireworks Display-</u>Borough Council approved the quote provided by Pyrotecnico in the amount of \$12,500 for the 2024 Community Carnival Fireworks Display on Saturday, June 8th.

Winter Mailbox Damage

The Borough of Seven Fields will not repair or replace mailboxes or posts that are damaged or fall over from the force of plowed snow and are not hit directly by the plow.

Mailboxes and supporting posts must be strong enough and installed in such a way to withstand the weight and force of snow removal including the force of snow pushed from the streets onto the side of the road.

At the Monday, January 8th Seven Fields Borough Council Meeting, Council President Regan-Koch outlined the following 2024 State of the Borough...

2024 Seven Fields State of the Borough

- No tax increase in the millage rate for the 14th year.
- No increase in water rates or monthly service charges since 2020.
- The General Fund Budget average increase since 2018 has been 3.58% & Water Fund Budget average increase has been 2.39%.
- The Borough has a reserve fund of \$1,350,515.
- The Borough retired the Series A Bonds a year early, which saved approximately \$20,000 in interest.
- Seven Fields has a Moody's Bond Rating of AA because we have an
 excellent Annual Debt to Annual Revenues Ratio and Fund Balances. To put
 this into perspective, Cranberry Township, has an AAA; because they
 continue to grow, and Seven Fields is done.
- Four-year Police Services Agreement with Northern Regional Police.
 Department
- 3-year Fire Services Agreement with Adams Area Fire District.
- 14-year Seven Fields Road Resurfacing Program, at an average annual spending of \$250,000 to maintain our streets.
- Spent \$68,668 on Phase I and \$90,534 on Phase II for renovation/upgrades at the Seven Fields Town Park Pool/Playground Restrooms.
- Received \$22,500 from Butler County Commissioners for the Butler County Park & Recreation Grant to upgrade Seven Fields parks & community pool three consecutive years.
- Received \$29,600 from the PA Recycling Performance Grant since 2018.
- Received a \$250,000 DCED-Local Share Account Reimbursement Grant for renovations at the Seven Fields Town Park Pool Complex from (filtration system, pool slide, concrete installation). This is Phase 3 of renovations at the Seven Fields Town Park Pool.
- Spent \$10,000 for Seven Fields Stormwater Maintenance.
- Spent \$14,912 for Installation of the Traffic Security Cameras at Seven Fields Intersections to Assist Local Enforcement.
- Spent \$24,336 in in upgrading Water Meters to New Digital Technology.
- Upgrading of Northern and Southern Detention Ponds after 30 years using Borough Public Works staff and \$162,450 in grant money.
- Multiple Seven Fields Community events that bring residents and nonresidents together, such as the Community Carnival, Beer, Wine, & Music Festival, Food Truck Nights & Seven Fields Light Up Night.

Borough Council Announces Traffic Safety Improvements at intersections along Castle Creek Drive & Highpointe Drive

To reduce driver roll-throughs and blow-throughs, the Borough of Seven Fields installed solar-powered LED flashing stop signs at Cumberland Drive, Warrick Drive, and Highpointe Drive intersections as part of the Seven Fields Traffic Calming Program. The public works staff have reduced the brightness of the lights to 75%, installed blinders to reduce glare, and lights are only operational from 5:00 a.m. to 10:00 p.m. These flashing LED traffic signs are intended to grab drivers' attention to stop at stop signs. This is a continued commitment to improve the safety of motorists and pedestrians throughout the community. The Borough of Seven Fields will continue to review safety improvements and implement traffic calming options.







PA Law Mandates Fines for Not Clearing Snow & Ice From Vehicles

Cars and Trucks now must be cleared of snow and ice within 24 hours of a snowstorm.

Drivers are now required to clear snow and ice from their vehicles within 24 hours of a snowstorm and before driving.

In July, Gov. Tom Wolf signed "Christine's Law," a bill named after Christine Lambert. She died while traveling on Christmas Day 2005 when an icy projectile dislodged from a tractor trailer, went through the windshield of her vehicle, and struck her in the head.

The new law says drivers must make "reasonable efforts to remove accumulated ice or snow from the motor vehicle or motor carrier vehicle, including the hood, trunk and roof of the motor vehicle or motor carrier vehicle, within 24 hours after the cessation of the falling snow or ice." Anyone found violating Christine's Law faces a \$50 fine. However, if ice or snow left on a car or truck flies off and causes injury, fines could be as much as \$1,500. The bill strengthened previous ice and snow removal laws in which drivers could be penalized only if snow or ice falling from their vehicle resulted in serious bodily harm.



ON-STREET PARKING RESTRICTIONS

The on-street parking restriction between 2:00 to 6:00 am is not just for snow removal. The need for rapid responses to fires and other emergencies is crucial for saving lives and property. The space that emergency responders need can vary considerably, depending on the (1) kind of fire apparatus and other emergency response equipment required and chosen by the department, (2) the type of incident and (3) the design of the neighborhood's streets.

Illegally parked vehicles could potentially impede access for emergency vehicles and emergency personnel. In an emergency, a few seconds literally can mean the difference between life and death.

The Northern Regional Police Department will be actively enforcing the Borough Parking Ordinance #46 - Providing Rules and Regulations for Parking and Operation of Motor Vehicles in the Borough.

Noncompliance will result in a warning notice being issued along with a \$25 penalty in accordance with **Ordinance 80.**
