**Borough of Seven Fields Statement
on Regional Police Department
June 13, 2023**

"Recently, the Evans City/Seven Fields Regional Police Department was informed by one of its officers that he intended to accept new employment outside the department. The officer has since departed the regional police department, and the Borough of Seven Fields wishes this officer well in his new role.

Though the regional police department's own staffing has been reduced to inadequate levels due to this and other resignations, the Borough of Seven Fields remains wholly covered by capable law enforcement partners from the Pennsylvania State Police and nearby police departments.

The regional police department remains the current contractual law enforcement service provider in Seven Fields. However, the mayor, borough council and borough manager continue to discuss a new model of police protection for Seven Fields and its residents. Borough representatives have identified two area police departments which have committed to partner with Seven Fields to offer adequate police services to the borough. Representatives are now in final discussions with each of these departments. The Borough of Seven Fields intends to formalize a partnership with one of the agencies by mid-summer.

The mayor, borough council and borough manager will inform residents of any significant developments from this process at upcoming council meetings, and through public channels such as newsletters, its website and social media platforms as time and confidentiality allow.

The safety of Seven Fields is our utmost priority and will remain so as we navigate any transformation of police services. We welcome questions from residents and stakeholders as this process moves forward."



In December 2022, Borough Council entered into a Peer-to-Peer Technical Assistance Agreement with the Pennsylvania Governor's Center for Local Government Services to perform a Police Services Study on future police coverage for the Borough of Seven Fields. WATER SYSTEM INFORMATION:

This report shows our water quality and what it means. If you have any questions about this report or concerning your water utility, please contact the Borough Office at (724)776-3090. We want our valued customers to be informed about their water utility. If you want to learn more, please attend any of our regularly scheduled meetings. They are held on the 2nd Monday of each month at 6:30 pm at the Borough Building located at 220 Garden Drive, Suite 100, Seven Fields.

SOURCE OF WATER:

Our water is purchased from West View Water Authority, which means our water source is classified as surface water.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

MONITORING YOUR WATER

Seven Fields Borough routinely monitors for contaminants in your drinking water according to federal and state laws. The following tables show the results of our monitoring for the period of January 1 to December 31, 2021. The State allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data is from prior years in accordance with the Safe Drinking Water Act. The date has been noted on the sampling results table. Some of our data is from West View Water Authority sample data and some are Seven Fields Borough sample data. It is noted in the table.

DEFINITIONS AND ABBREVIATIONS:

Action Level (AL) - The concentration of a contaminant, which, if exceeded, triggers treatment or other requirements, which a water system must follow.

Maximum Contaminant Level (MCL) - The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) - The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL) - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Minimum Residual Disinfectant Level - The minimum level of residual disinfectant required at the entry point to the distribution system.

Treatment Technique (TT) - A required process intended to reduce the level of a contaminant in drinking water.

Level 1 Assessment - A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.

Level 2 Assessment - A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an *E. coli* MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.

pCi/L = picocuries per liter (a measure of radioactivity)

ppb = parts per billion, or micrograms per liter (µg/L)

Unregulated Contaminant Monitoring Rule (UMCR)

Unregulated contaminants are those for which the EPA has not established drinking water standards. The purpose of unregulated contaminant monitoring is to assist EPA in determining the occurrence of unregulated contaminants in drinking water and whether future regulation is warranted. In addition to testing we are required to perform; our water system voluntarily tests for hundreds of additional substances and microscopic organisms to make certain our water is safe and of high quality. EDUCATIONAL INFORMATION

"If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Seven Fields Borough Water Department is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline or at <http://www.epa.gov/safewater/lead>."

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm water run-off, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can, also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA and DEP prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA and DEP regulations establish limits for contaminants in bottled water, which must provide the same protection for public health. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Second Quarter Water Bills

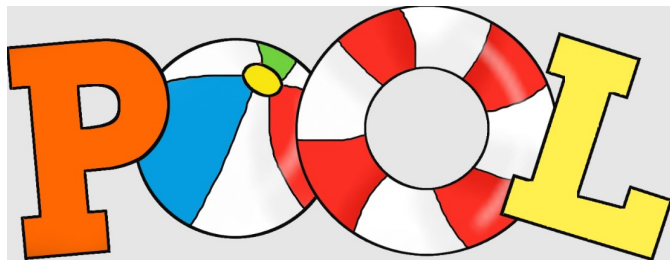
Meters were read at the end of June for water usage during the second quarter

Keeping citizens informed.

§ 340-43. Lighting standards.

In any district, any operation or activity producing glare shall be conducted that direct and indirect illumination from the source shall not be in excess of 1/2 footcandle above the ground, when measured at the height of three feet above the ground, at any lot line, except lighting at entrances and driveways to nonresidential properties, shall not exceed two footcandles when measured at the pavement at any lot line.

Flickering or intense luminaries or sign lighting shall be so controlled as to not cause a nuisance across any lot line. A nuisance is any illumination exceeding that which is necessary to accomplish the reasonable purpose for which the lighting is intended. Purposes are to provide for safety and minimum illumination of signs or structures for visibility by the owner or the public.

Nuisances shall be abated by controlling illumination or by shielding on the fixture.

Outdoor lighting illumination shall be limited within usable areas of the site to an average intensity, measured at the ground, of 25 footcandles with a maximum intensity at any given point on the ground of 80 footcandles unless otherwise approved by the Borough Council.

The Borough reserves the right to test lighting levels to verify conformance with the lighting plans accepted and approved by the Borough as part of the site plan review. If it is determined that the lighting levels exceed those which were approved by the Borough, the property owner will bear the cost of the lighting study. If it is determined that the lighting levels conform to the approved plan, the Borough will bear the cost of the study.

The height of the luminary measured from the base shall be limited as follows:

In any residential district, the maximum front pole luminary height permitted shall be 10 feet.

In any district, the maximum parking lot luminary height permitted shall be 15 feet.

In any district, the maximum street luminary height permitted shall be 15 feet.

In any district, the maximum height permitted shall be 20 feet.

Ball diamonds, playing fields, basketball, tennis courts and parks having unique requirements for nighttime visibility may be exempt if, in the judgment of the Borough, their limited hours of operation and the location of the luminaries will adequately protect neighboring uses.

To ensure Borough resident and visitor safety, all residential lots on which a dwelling is erected shall be required to have an exterior light pole emitting a minimum equivalent of 60 watts of light from dawn to dusk. All Ordinances can be found at sevenfields.org

WARNING!

How can you tell poison hemlock? Poison-hemlock **stems have reddish or purple spots and streaks, are not hairy, and are hollow.** Leaves are bright green, fern-like, finely divided, toothed on edges and have a strong musty odor when crushed. Flowers are tiny, white and arranged in small, umbrella-shaped clusters on ends of branched stems. Borough Council has a treatment contract with Davey Tree Experts.

PLEASE Avoid Contact– All parts of the poison hemlock are dangerous and toxic-the leaves, stem, roots, seed, and juices. PLEASE Keep Pets on a leash if they cannot be trusted not to eat the hemlock or mess with it.



ON-STREET PARKING RESTRICTIONS

The on-street parking restriction between 2:00 to 6:00 am is not just for snow removal. The need for rapid responses to fires and other emergencies is crucial for saving lives and property. The space that emergency responders need can vary considerably, depending on the (1) kind of fire apparatus and other emergency response equipment required and chosen by the department, (2) the type of incident and (3) the design of the neighborhood's streets.

Illegally parked vehicles could potentially impede access for emergency vehicles and emergency personnel. In an emergency, a few seconds literally can mean the difference between life and death.

The Evans City/Seven Fields Regional Police Department will be actively enforcing the Borough Parking Ordinance #46 - Providing Rules and Regulations for Parking and Operation of Motor Vehicles in the Borough.

Noncompliance will result in a warning notice being issued along with a \$25 penalty in accordance with Ordinance #80.

Ordinance #66 Section I Maintenance of Sidewalks

...Sidewalks, including all space between the property line and the curb line or vehicular driveway, even though the entire space may not be paved as a walkway for pedestrians shall always be maintained by the owner in a safe, unobstructed, level condition without abrupt variations in the surface.

Borough Officials are actively enforcing the Ordinance.

Ordinance #66 Section VI

Trimming of Trees and Other Plants Along and Above Sidewalks

...shall be the duty of such occupants and owners as aforesaid at all times to keep hedges, bushes, shrubbery and trees so trimmed as not to obstruct the sidewalk...or with the view of motorists at and along intersecting streets

...limbs of trees shall be deemed an obstruction if they are permitted to overhang the sidewalk at a **height of less than seven (7) feet...**

It's Hot Out!

Don't Leave Your Pet in the Car!



A car can overheat **even** when the window has been left cracked an inch or two.



Young, overweight or elderly animals, or those with short muzzles or thick or dark-colored coats are **most at risk** for overheating.



Shady spots offer **little** protection on hot days, and move with the sun.

90°

Even if the temperature outside is only 70°, the inside of your car may be as much as 20 degrees hotter!

102°

On an 85° day, it only takes ten minutes for the inside of your car to reach 102°.

120°

Within just 30 minutes, the car's interior can climb from 85° to a scorching 120°.



Many states and local governments have laws that prohibit leaving an animal unattended in a motor vehicle under dangerous conditions, which includes hot days. Your car could be damaged or you could be charged with a crime.

Protect your eyes

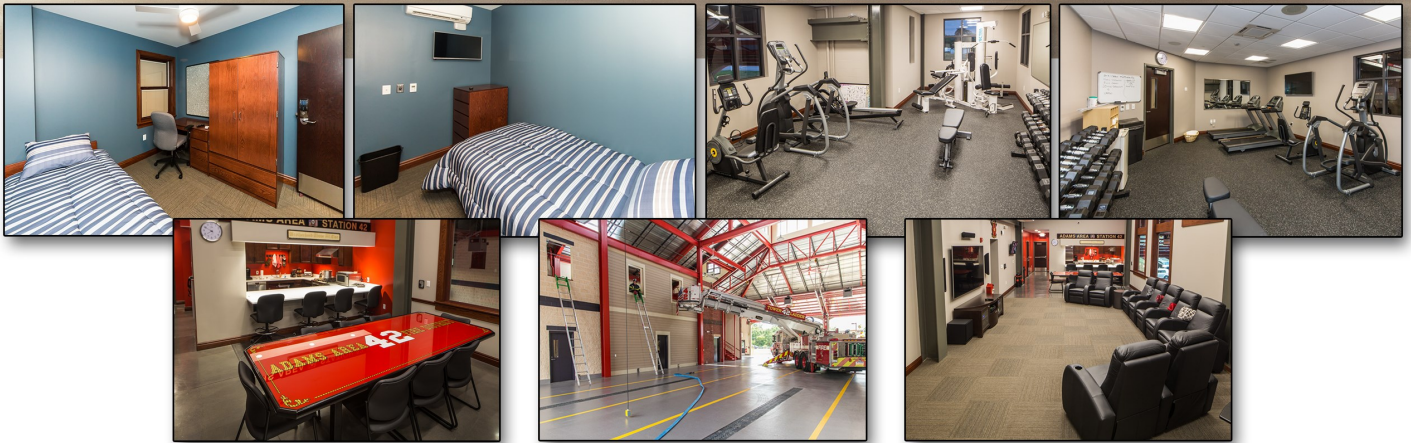

Reminder— a permit for open recreational campfires is required in the Borough.
Permits are valid for two (2) weeks from date issued.

- Open fires need to be safely contained and easily extinguished.
- It may be no larger than 5'x5' and burn no longer than five (5) hours.
- No Fire is to be left unattended.
- The official may order the extinguishment of such when it is a nuisance.
- Recreational campfires may be used in conjunction with the cooking of food.
- The use of fire for trash, leaf, brush, or construction material removal is *PROHIBITED*.

For permit to be valid it must be received in the Borough office prior to 4:30 pm the prior business day for distribution purposes.
