# Seven Fields

#### STATEMENT ON CURRENT POLICE SERVICES

For the past year, the Borough Council of Seven Fields has been working with the administration to secure new and proper police coverage for our residents. The current Evans City/Seven Fields Regional Police Department has long failed to meet its requirements; with only a chief and sergeant remaining, the level of police coverage is unacceptable.

Seven Fields is now very close to securing both a temporary patrol coverage partner, and a new long-term contract for law enforcement services from a neighboring department. In preparation, the Council recently passed a resolution authorizing withdrawal from the regional police department and dissolution of its commission.

However, as we prepare for this new future in policing, unfortunate obstacles remain. Our efforts to secure cooperation to contract separately for uncovered patrol shifts have been met with unreasonable demands for "buyouts" — demands from the two remaining members of the police department.

The sergeant is represented by a union which negotiates wages and benefits for officers. He is the only member of the union. The chief does not have union representation, but has taken no steps to support our need for coverage. He has not hired nor arranged for any alternative police support except the Pennsylvania State Police. We expect more from our officers, and for our community, but have received no support from the department or from Evans City to solve this immediate problem.

Instead, we have received demands including full salary payouts totaling more than \$410,000 over the next two years. The bargaining unit is also requesting family healthcare coverage for the sergeant until 2029. All told, the cost of funding these dead-weight demands approaches \$600,000 with Seven Fields covering nearly two-thirds — in addition to paying for our new police partner.

Unfortunately, the other municipality in this agreement appears to be siding with the officers. As the Cranberry Eagle noted in its August 9 report, Evans City's council president is "anxious for the issue to be settled" with a buyout and doesn't "want to stretch it out anymore." However, her own taxpayers are likely to be responsible for more than \$200,000 to pay out these same demands.

We urge our counterparts in Evans City to assist us in recognizing that the time for making concessions is over. The Borough Council of Seven Fields intends to secure temporary patrol services as soon as possible. If we do not, the current contract will run through 2025, and no borough should wait that long with only a two-person police department.

The short-term solution is clear: the remaining officers need to prioritize public safety and service, as their solemn oath requires, and sign to allow supplemental patrols to begin. Furthermore, Evans City needs to assist in getting this done for the benefit of all our residents.

A new patrol partner will ensure Seven Fields is able to properly protect and serve its residents. As long-term negotiations continue, we expect the two members of the Evans City/Seven Fields Regional Police Department to uphold the public's safety and security, and authorize temporary patrol assistance for the good of our people.

#### August 28th, 2023 Borough Council Meeting

<u>Amendment of Ordinance 83-</u>Establishing the Evans City/Seven Fields Regional Police Department-Borough Council authorized amending in part and repealing in part Ordinance No. 83 of 2013, to authorize the dissolution of the Evens City and Seven Fields Regional Police Department, revising the attendant police jurisdiction thereby assigned and otherwise amending the intergovernmental cooperative standards.

<u>Legal Ad for RFP for Seven Fields Stormwater Retention Pond Remediation Project</u>
Borough Council authorized the legal advertisement for RFP for the Seven Fields Stormwater Retention Pond Remediation Project.

<u>Seven Fields Storefront/Entry Renovation Project-</u>Borough Council awarded the Front Entrance Glass Replacement Project to DiSalvatore Group LLC in the amount of \$123,884.88.

**<u>2023 Speed Plateau Installations Payment-</u>** Borough Council authorized payment in the amount of \$90,000 from Liquid Fuels to Shields Paving for nine of the ten speed plateaus.

<u>Southridge Drive Paving Payment-</u>Borough Council authorized payment in the amount of \$21,885.65 from Liquid Fuels for the paving of Seven Fields portion of Southridge Drive.

**2023** 1<sup>st</sup> Half Budget & Water Analysis-Borough Council reviewed the 1st Half Budget & Water Analysis noting total revenues have increased year over year by \$138,532. The General Fund ended the first half with a \$322,563 surplus. Water Fund revenues increased by \$28,562. The Water Fund ended the first half with a \$119,779 surplus.

<u>Seven Fields Community Center Front Door Software-</u>Borough Council authorized payment in the amount of \$2,155.95 to North Hills Lock & Safe to install a new Emerge Access System for the programming of the Community Center Doors.

<u>Hillvue Drive Tree Removal-Borough</u> Council authorized payment in the amount of \$2,400 to RB Tree Services for removal of a two-stalk Willow Tree at the entrance of Hillvue Drive that was clogging the 24" storwater drainage system.

## PEDESTRIAN SAFETY
